### 2. School Update

#### a. School Improvement Plan (SIP) review

- i. SIP was submitted to the district office today
- ii. The District has set out 4 goals: Literacy, numeracy, safe and cared for, graduation
- iii. Sandra presented Birchmount's data on
  - 1. Current reality: Newcomers, PLPs
  - 2. Literacy: Below average in most areas, but we are areas of success
  - Numeracy: Below average in most areas, but we are areas of success
  - 4. Safe and Cared For: This is an area for celebration for Birchmount
    - a. Some data is old and only taken at the beginning of the year so may be different if taken later in the year
  - 5. Graduation Rates: Graduation rates given for 2017 and 2018 cohorts (~88%)
- iv. Prioritized Gaps
  - 1. Early Literacy
  - 2. Grade 4 and 6 Reading results
  - 3. Middle level numeracy
  - 4. Lack of high expectations and feeling safe from staff
- v. Belt Committee met with the District SIP team to complete a cause analysis to determine which factors had the greatest impact on the cause (low reading assessments)
- vi. Staff brainstormed ideas that can make an improvement.
  - 1. Quick fixes were identified to be implemented.
  - 2. The SIP focused on the larger, more effort ideas
- vii. Birchmount's Big Ideas
  - Literacy Using the Building Blocks of Reading with fidelity and consistency

- 2. Numeracy Implementing a hands-on, life skills math program for the middle school
- 3. Safe and Cared For PBIS
- viii. Next step: the school team will meet with district staff to review the SIP and determine which supports are needed

### b. Positive Behaviour Intervention Supports update

- i. We have renewed our commitment to be in this pilot
- ii. 3 returning members and 4 new ones
- iii. Birchmount's Behaviour Matrix has been created (shown to members tonight)
  - 1. This will be launched to students on Thursday followed by sending it out to the parents and posting it on the school website
- iv. Next step is to create the continuum of interventions

- ii. 4 recommendations were made
  - 1. Update old camera system we are updating our camera system

    - c. The stairwells are the worrisome areas as well as the wooded areas and the dumpster area
